## CASE STUDY

### ISSUE:

Our client was managing subsidiaries in 14 different countries, with widely different domestic risk profiles and activities. We needed to know where to focus limited resources?

### SOLUTION:

Out assessment focus on the drivers of risk, not documents. Considering the themes and causes that lead to risk – external environment, controls, and behaviours.

We established the common hotspots for the SECTOR – as what you do has a greater bearing on risk (usually) than where you do it.

### OUTCOME:
